

APPLYING FOR SECONDARY MEMBERSHIP

An individual is a **Secondary Member** if they pay current Arizona Association of REALTOR® (AAR) dues and National Association of REALTOR® (NAR) dues through another association/board.

Follow these easy steps:

- 1. Fill in the attached form. Sign and date it on page 3.
- 2. Fill in and sign the appropriate MLS Participation Agreement
 - a. For Agents: MLS Participation Agreement for Agents
 - b. For Brokers: MLS Participation Agreement for Designated Brokers
- 3. Dues and fees must be paid in full.
- 4. As a Secondary Member, you are required to provide SVVAR with a Letter of Good Standing from your Primary Association. Please request this letter from them to send to info@svvar.com
- 5. You may want to make your Supra eKey cooperating with us. There is a one-time \$50 Fee in addition to the dues and fees above.
- 6. Email the completed forms to info@svvar.com.

Effective January 1, 2020, each REALTOR® member of the association (with the exception of REALTOR® members granted REALTOR® Emeritus status by the National Association) shall be required to complete ethics training of not less than two (2) hours and thirty (30) minutes of instructional time. This requirement will be satisfied upon presentation of documentation that the member has completed a course of instruction conducted by this or in partnership with another association, the State Association of REALTOR®, the NATIONAL ASSOCIATION OF REALTORS®, or any other recognized educational institution or provider which meets the learning objectives and minimum criteria established by the NATIONAL ASSOCIATION OF REALTORS® from time to time. REALTOR® members who have completed training as a requirement of membership in another association and REALTOR® members who have completed the New Member Code of Ethics Orientation during any three (3)-year cycle shall not be required to complete additional ethics training until a new three (3)-year cycle commences. Any member who obtains a full C2EX Endorsement and keeps it maintained can use it to satisfy the Code of Ethics requirement.

Failure to satisfy the required periodic ethics training shall be considered a violation of a membership duty. Failure to meet the requirement in any three (3)-year cycles will result in suspension of membership the year following the end of any three (3)-year cycle until the requirement is met.
